Filing this application through our Online Filing Centre (corporationscanada.ic.gc.ca) or by paper costs \$200.

### Item 1

The current corporate name can be found in the articles of the corporation or by using "Search for a federal corporation" on Corporations Canada's website.

### Item 3

Any changes in the articles of the corporation must be made in accordance with section 27 or 177 of the CBCA.

- A: If an amendment involves a change of corporate name (including the addition of the English or French version of the corporate name), the new name must comply with sections 10 and 12 of the CBCA as well as part 2 of the regulations, and the Articles of Amendment must be accompanied by a Nuans Name Search Report dated not more than ninety (90) days prior to the receipt of the articles by Corporations Canada. A numbered name may be assigned under subsection 11(2) of the CBCA without a Nuans Name Search Report.
